MedSign CEO and co-founder Tom Conroy designed television technology for telehealth so that his 95-year-old father, a WWII veteran, who didn't use a computer or own a smartphone, and others like him could access both the video and audio components for telehealth. The technology is called Qortex, and the Department of Veteran's Affairs is expressing interest, with an estimated cost to providers of \$99 per month.
